

## TEXAS GRANT AND TEOG PROGRAMS APPLICATION

### TEXAS GRANT

To be eligible for this program, a student must:

- Be a Texas resident
- Have completed one of these high school programs
  - Recommended
  - Distinguished
- Enroll in a non-profit public college or university in Texas within 16 months of graduation from a public or accredited private high school in Texas
- Have accumulated no more than 30 semester credit hours, excluding those earned for dual or concurrent courses or awarded credit by examination (AP, IB or CLEP)
- Complete the Free Application for Federal Student Aid (FAFSA) with results sent to MCC
- Show financial need
- Have not been convicted of a felony for a crime involving a controlled substance
- Maintain a 2.5 grade point average and complete at least 24 semester hours in order to be eligible for future awards.

### TEXAS EDUCATIONAL OPPORTUNITY GRANT

To be eligible for this program, a student must:

- Be a Texas resident
- If applying for his/her first award, have a family contribution of no more than \$2,000
- Complete the Free Application for Federal Student Aid (FAFSA) with results sent to MCC
- Show financial need
- Be enrolled in at least six (6) credit hours
- Have completed less than 30 credit hours, and be enrolled in a Certificate or AAS degree plan
- Not be eligible for an award through the original TEXAS Grant Program
- Not have been granted an Associate or Baccalaureate degree
- Have not been convicted of a felony for a crime involving a controlled substance
- Meet the school's Satisfactory Academic Progress (SAP) requirements to be considered for future awards.

If you meet all of the above listed requirements for either program, please complete the application below and return to the Financial Aid Office at MCC along with a copy of your final high school transcript or GED certificate. Incomplete application packets will not be processed.
