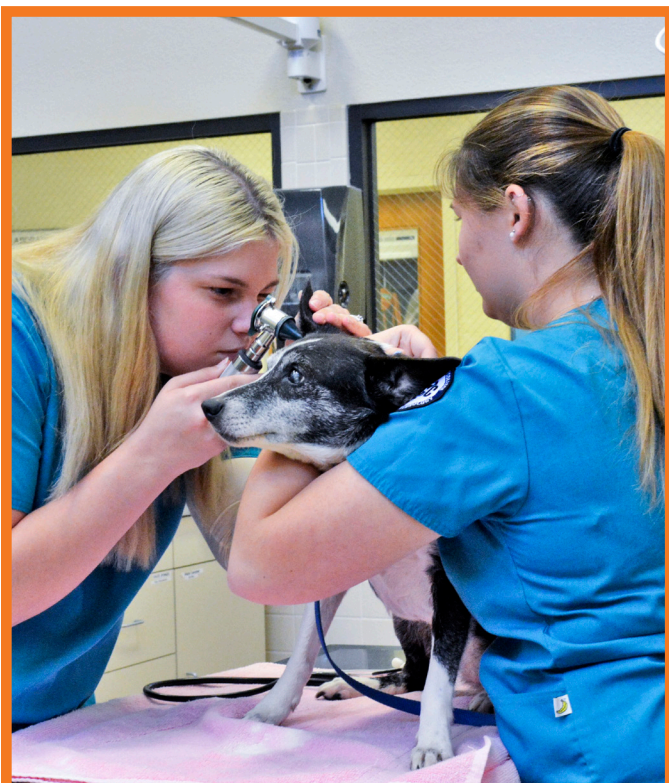




Veterinary Technology

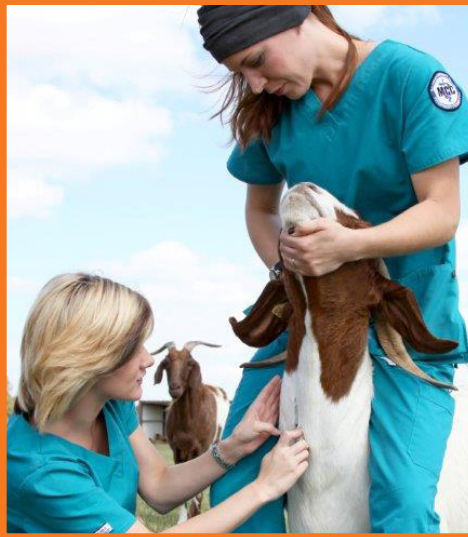

Admission Requirements

Acceptance to the Veterinary Assistant and the Veterinary Technology programs are by admission selection. Applications are due by June 15 for the following academic year.

Admission to the Veterinary Assistant certificate program requires:

- Fulfillment of TSI requirements
- Completion of 25 volunteer hours at a veterinary facility

Admission to the Veterinary Technology program is competitive, and typically, applicants must score higher than the minimum requirements to be accepted:

- Meet the minimum required score on the ATI-TEAS exam
- Completion of prerequisite courses
- Fulfillment of TSI requirements
- Completion of 50 volunteer hours at a veterinary facility
