The Board reviewed the resolution declaring the intent to raise McLennan Community Junior College District property taxes for 2022 tax year to an amount in excess of the 2021 tax levy, calling, and setting the date of public hearing to receive comments on the proposed increase and directing the publication of the notice of the public hearing as required by law. Mr. Stinnett moved to adopt a resolution with the intent of raising the tax rate above the calculated no-new-revenue tax rate but below the rollback rate. The intent being to increase the M&O rate by <u>5.462%</u> which would set the total rate at \$0.149782 per \$100 property valuation at the regular board meeting in August. The Public Hearing will be held on August 31, at 6:00 p.m., via Zoom. Mr. McDurham seconded the motion. The motion carried unanimously.
