Mr. Earl Stinnett, Chairman of the Board, called the Regular Meeting to order at 6:00 p.m.

Dr. Johnette McKown introduced the guests present at the regular meeting.

Dr. Wichman led a discussion of the 2025-2026 Annual Priorities. (D.F. V—820)

Mr. Harmsen presented the proposed 2025-2026 General Fund and Capital Improvement Fund Budgets. (D.F. V—821)

Mr. Harmsen presented a resolution declaring intent to raise McLennan County Junior College District property taxes no higher than 0.131974 for the 2026 Tax Year to an amount in excess of the 2025 tax levy, calling, and setting the date of the public hearing to receive comments on the proposed increase and direct the publication of the Notice of Public Hearing as required by law.

Dr. Clark moved to approve the resolution declaring intent to raise McLennan County Junior College District property taxes no higher than 0.131974 for the 2026 tax year to an amount in excess of the 2025 tax levy. The Public Hearing with take place on August 26, 2025. Mr. Hill seconded the motion, and it carried unanimously.

Dr. McKown introduced the four various groups represented at the Board Meeting, and a few leaders gave a quick update on their area.
