Procedures for Collection of Fees

- Students should pay testing fees and schedule appointments online through Register Blast software on the Testing Center's webpage:

 <u>https://www.registerblast.com/mclennan/Exam</u> or by contacting the Testing Center directly. Register Blast charges students a service fee per exam. Service fees are \$1.50 for exams that are \$10 or less and \$3.50 for exams that are \$11 or more.
- 2. Students paying for exams with cash need to visit Financial Services. Financial Services will collect the appropriate exam fees and issue a numbered receipt students will take to the Testing Center to set up an appointment.
- 3. All testing fees are non-refundable and non-transferrable.
- Register Blast issues McLennan Community College a direct deposit for the fees collected once a month. Fees should be credited to account number 10-013230-46530-0.
- 5. Financial Services will provide the Coordinator, Testing Services an account analysis report for account 10-013230-46530-0 at the end of each semester.
- 6. Individuals taking GED will register and pay through ged.com. PearsonVUE issues McLennan Community College a monthly payment for these exams. PearsonVUE payments should be credited to account 10-013230-46530-0.
