## New Business

- I. Reports from committees
  - a. Mary Sides: Policy E-XXI & Vote
    - i. Changes to E-XXI Increase course release for FCP and include a course release for FCVP. Other changes were reviewed. Faculty Council will vote, then faculty will vote if approved, then it will go to admin if approved.
    - ii. Discussion about whether the course release can be declined.
    - iii. Still working on changes to make the leadership roles more equitable/available to workforce colleagues. Recognition of time challenges. Suggestions are welcomed.
    - iv. Vote on policy E-XXI changes: Passed 21 for, 5 against. Next election will proceed.
  - b. Donald Keltner and Andrew Clayton: Elections
    - i. We will have to have a special election about the policy changes to E-XXI. One other special election needed because of an error on the tenure conversion committee ballot. This will be on the same ballot.
  - c. Donald Keltner: Bookstore Committee
    - i. Item of interest-the new e-reader system in the fall is called Kortext.

More information coming. If you offer a bonus for attendance this will be more difficult. The option is for faculty to embed Niche Academy resources in Brightspace and keep attendance themselves. Is there a faculty need for an easier option to take attendance? Thanks to colleagues at the library for all their work.
