**TERMS TO KNOW:**

A **freshman** is a student who has completed <30 credit hours, or any student enrolled in a certificate program.

A **sophomore** is any student who has completed 30+ credit hours.

**Subsidized loans** are need-based, and do not accrue interest while the student is enrolled in school at least half-time (6 or more credit hours per semester).

**Unsubsidized loans** are available to any student, regardless of need, whose other financial aid does not meet the cost of attendance. Unsubsidized loans accrue interest from the time they are awarded.

**1 Term loans are split into 2 equal disbursements:**

- 1<sup>st</sup> Disbursement- Beginning of the term
- 2<sup>nd</sup> Disbursement- Midpoint of the term

Per federal guidelines **first time loan borrowers** first disbursement must be delayed until 30 days after classes begin

**ONCE AWARDED, STUDENTS MUST VISIT WEBADVISOR AND ACCEPT THESE LOANS.**
