To receive an **initial** award through the TEOG Program, a student must:

- Be registered with Selective Service;
- have unmet need as defined by the annual TEOG updates from the Coordinating Board
- Be classified by the institution as a Texas Resident;
- Have not been convicted of a felony or crime involving a controlled substance;
- Be enrolled at least half-time and awarded in the first 30 hours (or its equivalent) of an associate's degree or certificate program (excluding credits for dual enrollment or by examination

To receive a renewal award through the TEOG Program, a student must:

- Be enrolled at least half-time as a student who previously received a TEOG award and has not yet been granted an associate's degree or baccalaureate degree;
- have unmet need as defined by the annual TEOG updates from the Coordinating Board
- Maintain satisfactory academic progress: 2.5 Cumulative GPA and 75% successful completion of attempted hours.
- Attempted fewer than 75 college semester hours (eligibility is lost once 75 attempted hours is reached).

If verification of FAFSA is required, verification must be completed before TEOG is applied. Funding is limited and amounts are subject to change.
