### **Admission Criteria**

Meeting the criteria does not guarantee acceptance into the program.

#### A. TSI

Applicant must be TSI complete prior to admission to the program.

#### B. Minimum 2.8 GPA (cumulative GPA) required for the following 3 courses:

HITT 1205 Medical Terminology I

HITT 1301 Health Data Content and Structure

HITT 1441 Coding and Classification Systems

Only 2 attempts permitted. The highest score will be used. Classes must be taken within past 5 years.

#### C. Background Check

Background check must be completed by company designated by HITT program. Student admission will be dependent upon conviction and conviction date according to policy. (See Program Director for details).

Applicants are admitted to the program in order of priority until the enrollment limit has been filled. **Meeting the criteria does not guarantee admission to the program.** Students typically must score higher than the minimum requirements to be accepted. Decisions are made by the Health Information Technology Admissions Committee.
